

THREE OAKS TOWNSHIP
BERRIEN COUNTY, MICHIGAN

Ordinance Number 33

WHEREAS, the Three Oaks Township Board may adopt an ordinance regulating the public health, safety, traffic, the use of streets, highways and alleys, and

WHEREAS, Three Oaks Township has an established police department with full power to enforce Township ordinances and state laws, and

WHEREAS, the Township Board deems it in the best interests of its citizens to adopt the Michigan Vehicle Code (1949 P.A. 300, MCL 257.1 to 257.923) by reference,

NOW, THEREFORE, the Township of Three Oaks hereby ordains the adoption of the Michigan Vehicle Code (P.A. 300, MCL 257.1 to 257.923), as amended and as it may be amended from time to time, by reference.

Section 1. Code Adopted.

The Michigan Vehicle Code (1949 P.A. 300, MCL 257.1 to 257.923) and its amendments as adopted and passed by the Legislature and signed by the Governor is hereby adopted by reference as in this ordinance.

Section 2. References in Code.

References in the Michigan Vehicle Code for "governmental units", shall mean the Township of Three Oaks.

Section 3. Notice to be Published.

The Township Clerk shall publish this ordinance in the manner required by law and shall at the same time publish the purpose of the Michigan Vehicle Code and the fact that a complete copy of the Michigan Vehicle Code is available at the Office of the Clerk for inspection by the public at all times.

Section 4. Conflicting Ordinances Repealed.

All ordinances inconsistent with the provisions of the Michigan Vehicle Code are, to the extent of such inconsistency, hereby repealed.

Section 5. When Effective.

This ordinance adopting the Michigan Vehicle Code shall be in effect thirty (30) days after the publication of a summary of the adopting ordinance.


