WHEREAS, the Three Oaks Township Board wishes to provide police services protection for Three Oaks Township; and

WHEREAS, townships may provide for police services protection as authorized by Public Act 1989, No. 81 as amended (MCL 41.801 et seq.), and Public Act 8, Extra Session of 1967 as amended (MCL 124.531 et seq.); and

WHEREAS, townships may contract and cooperate with other entities to provide police service protection as authorized by the Michigan Constitution of 1963 and other laws; and

WHEREAS, townships may impose and levy ad valorem property taxes to finance lawful public services, as authorized by the Michigan Constitution of 1963 and other laws; and

WHEREAS, the Three Oaks Township Board wishes to increase its levy to 1.75 mills for police service protection;

NOW, THEREFORE, BE IT RESOLVED that the Three Oaks Township Board, Berrien County, Michigan, approves the following millage ballot question language and directs the Clerk to submit it to be placed on the August 4, 2020 election ballot:

**POLICE PROTECTION MILLAGE PROPOSAL**

Shall Three Oaks Township impose an increase of 1.75 mills (\$1.75 per \$1,000 of taxable value) in the tax limitation imposed under Article IX, Section 6, of the Michigan Constitution and levy it on real property for a period of four years, 2021 through 2024 inclusive, for the purpose of providing funds for Three Oaks Township Police Protection Services including for police services protection for Three Oaks Township pursuant to a contract for police protection (law enforcement services agreement)? It is estimated the revenue collected by Three Oaks Township as a result of this proposal will be \$101,053.00 in the first year the millage is levied based on the most recent taxable value.
